- 3 The Indian Accounting Standards (Ind AS), as notified under the Companies (Indian Accounting Standards) Rules, 2015 are applicable to Bemco Hydraulics Limited (the "Company") commencing from 1st April, 2017, being the date of adoption of Ind As by the Company. Accordingly these unaudited financial results have been prepared in accordance with these standards as specified under section 133 of the Companies Act, 2013 read with relevant rules issued there under. The date of transition is April 1, 2016. The impact of transition has been accounted for in the opening reserve and imparative periods have been restated accordingly.
- 4. Consequent to the applicability of Goods & Services Tax (GST) w.e.f. 01-07-2017, Revenue from Operations for the quarters ended 30-09-2017, 31-12-2017 and 31.03-2018 are disclosed net of GST while figures for the year ended 31-03-2018 includes excise duty up to 30-06-2017. Also, Revenue from Operations for the quarter and nine months ended 31-03-2017 includes Excise Duty and hence not comparable.
- 5. The Company is in a single Business Segment 'MANUFACTURING OF HYDRAULIC PRESS MACHINES & EQUIPMENTS'. These, in the context of Ind AS 108 on "Operating Segments" are considered to constitute one reporting segment.
- 6. The figures for the corresponding previous period have been regrouped/ reclassified wherever necessary, to make them comparable. The figures for quarter ended 31st March 2018 are the balancing figures between the audited figures in respect of the full financial year and the reviewed year-to-date figures up to the third quarter of the financial year.
