

To evade cops, 2 'gamblers' jump into river, go missing

TO avoid being caught by the police, two youths playing cards jumped into Malaprabha river near Ramdurg only to go missing later. They are feared dead, as the fire and emergency services officials are summoned to trace them in the water.

The youths are identified as Manju Bandiwaddar (30) and Sameer Batkurthi (22) and efforts are on to trace them.

According to sources, a group of youths was playing cards on the banks of Malaprabha river. Following a tip off, a police team raided the suspected gamblers. While some among them succeeded in making good their escape, six jumped into the river nearby to escape from the police. While four of them managed to swim to safety, two others went missing.
